As our swimmers begin to enter the senior level of competition, our intent is to expose our members to experiences that they will more than likely be subject to at the collegiate level. This transition includes developing a level of independence and responsibility that is not as common at the age group level. Parents are asked to help in this development by encouraging this independence in minimizing contact with swimmers during the swim meet. Swimmers are encouraged to travel with the team without their parents(s), and parent(s) are asked to not sit in the swimmer area during the swim meet. Each swimmer is expected to review, sign, and adhere to the Tule Nation Triton Travel Policy and Code of Conduct, as well as information presented in documents associated with the travel, including this page.

Notes and Tentative Plans:

- The van will depart from:
 - o Fresno at 9:00 AM.
 - A second van will depart from the Westin of Visalia at 10:00 AM,
 - A final pick-up will be at 10:20 in the parking lot of Big Kahuna Frozen Yogurt located at 1297 N Cherry Street in Tulare
- A brief 30-minute lunch stop will be scheduled in Lebec.
- We will travel straight to the pool for those entered into the 800 freestyle on that day. The meet starts at 4:00 PM
- The total travel cost is \$323 which includes the room (@\$153), and meals (@\$170). The travel cost is not modified for individual deviations from the travel itinerary.
- Travel plans are tentative (including meals), and may change based on need.
- All swimmers are expected to support the team at finals.
- Families who are planning on attending the meet are informed that there is a \$3 spectator fee for prelims, and an \$8 spectator fee for finals. A day pass can be purchased for \$10. There is also a fee required for parking on campus.
- We will determine relay participation once at the meet. These were not pre-entered.
- Chairs are not needed at this meet since stadium seating is available for swimmers and spectators.
- Time Trials are sanctioned for this meet. Swimmers who do not have an individual event on any day are expected to enter time trials. Time trials are deck-entered, and swimmers must pay the entry fee (\$15) on the day of the event. Swimmers are encouraged to enter time trials as early as possible, in case of limitations set on participation by the meet host. Time trials for distance events are offered on Friday only. We will not participate in time trials following finals on Sunday.
